Section 3 of the "Classification of Residency for Admission and Tuition Assessment Purposes" requires that residency shall be based upon a preponderance of evidence; verifiable circumstances substantiated by submission of original or notarized copies of relevant evidence. **Following is a list of suggested documents that may be submitted for tuition assessment purposes, as determined by your circumstances.** Other documents may be requested by the institution or may be provided as the student desires.

#### \*Examples of Documentation to Support a Request for Reclassification of Residency for Tuition Assessment Purposes

#### Dependency of a Parent/Legal Guardian Whose Primary Residency is Kentucky

- Copy of birth certificate or court order awarding guardianship prior to admission. **Or**
- Copy of parental tax filing for the calendar year immediately preceding the date of application for reclassification of residency. **And**
- Copy of parental property deed to primary Kentucky residence or copy of lease agreement of non-collegiate housing. **And**
- Copy of most recent financial aid award notice and/or student aid report. And
- Verification of parent's present, primary address (i.e. current utility bill, bank statement). And
- Copy of parent and student current Kentucky driver's license.
- Other documentation relevant to your situation and which might be supportive of your request for determination of residency status.

# Domicile in Kentucky as a non-student or part-time student for 12 consecutive months preceding the first day of classes for the term you are applying:

- Copy of property deed to primary Kentucky residence or copy of lease agreement of non-collegiate housing for the 12 months preceding the first day of classes of the term which you are applying. **And**
- Verification of present address (i.e. current utility bill, bank statement). Must be an item not already requested. **And**
- Copy of your current Kentucky driver's license.
- Other documentation relevant to your situation and which might be supportive of your request for determination of residency status.
- Please note that staff will verify your non-student or part-time student status for the 12 consecutive months preceding the first day of classes for the term you are applying. Part time student status is defined as Undergraduate (6 or fewer hours per semester), Graduate (4.5 or fewer hours per semester)

#### Marriage to Kentucky Resident:

- Copy of marriage license.
- Copy of property deed to primary Kentucky residence or copy of lease agreement of non-collegiate housing.
- Verification of present address and that of spouses. (i.e. current utility bill, bank statement). Must be an item not already requested.
- Copy of your Kentucky state income tax forms (Form 740 and all schedules) for the calendar year immediately preceding the date of application for reclassification of residency status and for the previous year. (if applicable)
- Copy of spouse and your current Kentucky driver's license.
- Other documentation relevant to your situation and which might be supportive of your request for determination of residency status.

#### Full time employment or job transfer in Kentucky:

- Letter from employer on official company letterhead verifying job transfer or acceptance of full-time employment giving date of employment, average number of hours worked per week, and whether the job is permanent or temporary.
- Copy of current paystubs verifying current employment status, hours worked per week.
- Copy of statement from parent regarding financial support.
- Copy of property deed to primary Kentucky residence or copy of lease agreement of non-collegiate housing for the 12 months preceding the first day of classes of the term which you are applying. **And**
- Verification of present address (i.e. current utility bill, bank statement). Must be an item not already requested.
- Copy of your Kentucky state income tax forms (Form 740 and all schedules) for the calendar year immediately preceding the date of application for reclassification of residency status and for the previous year.
- Verification of payment of occupational taxes in Kentucky.
- Copy of your current Kentucky driver's license.
- Other documentation relevant to your situation and which might be supportive of your request for determination of residency status.

\*This is an outline of examples of documentation that may be used to support your appeal for residency. This is not meant to be all inclusive. In addition, certain extenuating circumstances may be taken into consideration in making a determination of residency.
